

Privacy Statement silver mango

Introduction:

This declaration applies to all products and services provided by silver mango.

silver mango, based in Amsterdam, is responsible for the processing of personal data as shown in this privacy statement.

Personal information we process

silver mango processes your personal data because you use our services and/or because you provided it to us yourself. Data which you may need or are necessary for the purposes described below and which are processed by silver mango in any case and at least:

- Initials and last name
- Gender
- Date of birth
- Company Name
- Address information (consisting of street name + house number + postal code)
- Phone number (mobile or fixed)
- E-mail address AND
- Bank details

Does silver mango also process special personal data?

Special personal data are sensitive data, for example on health or criminal history, ethnic data or data on race. silver mango does not process any special personal data.

Why we need data

Once you have an agreement with silver mango, we want you to be well served. We use your information for the following purposes:

- you can call or e-mail if necessary to perform our services.
- inform you about changes to our services and products.
- to deliver goods and services to you.
- If we are legally obliged to do so, such as information we need for our tax return.
- Data can also be used for promotional or marketing purposes, which are proportional to the type of service provided by silver mango. For example, to inform you via our newsletter about a new activity of silver mango. If you do not wish to be contacted via our newsletter, you can unsubscribe to this newsletter by clicking 'unsubscribe' at the bottom of the newsletter.

We can only use your data for a different purpose, than for which they were originally processed, if there is a close relationship between the two purposes.

What rules apply when processing personal data?

When processing personal data, silver mango is bound by the applicable data laws and regulations and keeps track of developments in them. In this context, silver mango reserves the right to make changes to this privacy statement in order to match the text with the latest state of affairs, as stated at the bottom of this privacy statement.

How long we keep data

silver mango does not retain your personal information for longer than is strictly necessary to achieve the goals for which your data is collected.

Sharing with others/providing data to third parties

silver mango does not sell your data to third parties and only provides it if necessary to execute our agreement with you or to comply with a legal obligation. With companies that process your data in our order, we conclude a processing agreement to ensure the same level of security and confidentiality of your data.

Site Visit Mapping (Public Section)

silver mango uses only technical and functional cookies. A cookie is a small text file that is stored on your computer, tablet or smartphone on the first visit to our websites. The cookies we use are necessary for the technical operation of the websites and your ease of use. They make sure that the websites work properly and remember your preferences, for example. You can opt out of cookies by setting your Internet browser to stop storing cookies. In addition, you can also delete any information previously saved through your browser settings.
